SOMETIMES BROUGHT ABOUT BY GENETIC MUTATIONS BUT NOT ALWAYS

THE PENGUIN (BIRD):

- CAN'T BREATHE UNDERWATER LIKE A FISH;
- CAN'T MATE WITH A FISH OR PRODUCE VIABLE PROGENY WITH FISH.
- CAN'T EVER EVOLVE INTO ANOTHER "KIND" OF ANIMAL SUCH AS FISH OR DOLPHIN. MACRO-EVOLUTION HAS NEVER BEEN OBSERVED IN NATURE, EVER. IT IS A GREAT HOAX.
- GENETIC MUTATIONS CAUSE VARIATIONS LEADING TO ADAPTATION TO ENVIRONMENT



- THIS CHIMPANZEE HAS ADAPTED TO CRACKING NUTS BY LEARNING THE USE OF TOOLS (rock)
- CHIMPS CANNOT MATE WITH HUMANS AND PRODUCE VIABLE PROGENY.
- IT NEVER EVOLVES INTO ANOTHER KIND OF ANIMAL. MACRO-EVOLUTION HAS NEVER BEEN OBSERVED IN NATURE, EVER. IT IS A GREAT HOAX.
- ADAPTIVE SKILL MIGHT LEAD TO NATURAL SELECTION BUT NOTHING MORE.



NATURAL SELECTION PROCESS

NATURE AND ENVIRONMENT SELECTS OUT THE WEAK OR THOSE WITH CERTAIN UNFAVORABLE TRAITS

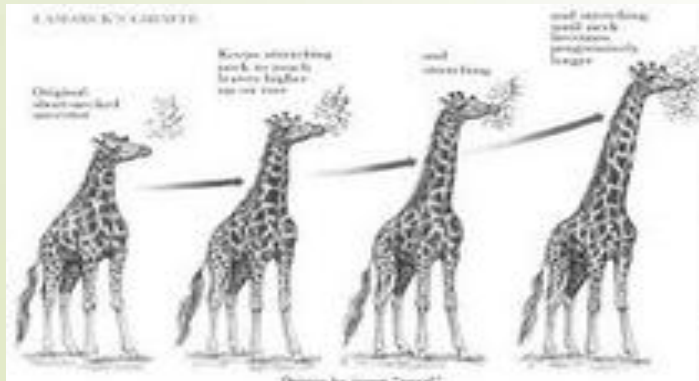


- ▶ THIS BIRD IS MORE LIKELY TO SELECT OUT THE LIGHT COLOURED MOTHS BECAUSE THEY ARE EASIER TO SEE.
- ▶ **NATURAL SELECTION PROCESS NEVER ALLOWS ONE "KIND" OF CREATURE TO EVOLVE INTO ANOTHER "KIND" OF CREATURE. LIGHT OR DARK, THEY ARE STILL ONLY MOTHS. MACRO-EVOLUTION HAS NEVER BEEN OBSERVED IN NATURE, EVER. IT IS A GREAT HOAX.**

- 1) IF THE DARK COLOURED MOTHS SURVIVE BETTER, **DOES THAT MEAN THEY BECOME ANOTHER KIND OF CREATURE SUCH AS A BIRD, BAT, FROG, OR TURTLE? OF COURSE NOT!!!**
- 2) IF THE LIGHT COLOURED MOTH AND THE DARK COLOURED MOTH MATE AND PRODUCE GREY COLOURED MOTHS, **ARE THEY STILL MOTHS OR ARE THEY BIRDS, BATS, OR SQUIRRELS? IT IS ALWAYS ONLY MICRO-EVOLUTION NOT MACRO**

NATURAL SELECTION PROCESS: BROUGHT ABOUT BY GENETIC MUTATIONS

- THE SHORTER NECKED GIRAFFES WILL STARVE WHILE THE LONGER NECKED GIRAFFES ARE MORE LIKELY TO SURVIVE AS THEY CAN EAT THE FOODS HIGHER UP WHICH SHORTER NECKED GIRAFFES CANNOT REACH, **BUT THEY NEVER EVOLVE INTO ELEPHANTS OR BIRDS. MACRO-EVOLUTION HAS NEVER BEEN OBSERVED IN NATURE, EVER. IT IS A GREAT HOAX.**



- IF BIRDS LIKE THE TASTE OF THE GREEN BEETLES, THIS ONLY MEANS MORE PINK BEETLES ARE LIKELY TO SURVIVE OVER TIME, **BUT THE PINK BEETLES NEVER EVOLVE INTO BIRDS OR MONKEYS OR ANY OTHER KIND OF CREATURE. MACRO-EVOLUTION HAS NEVER BEEN OBSERVED IN NATURE, EVER. IT IS A GREAT HOAX.**

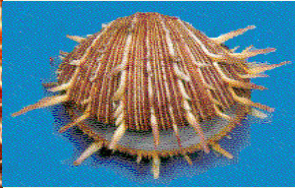


WHAT DARWIN ADMITTED, "ORIGIN OF SPECIES"

- ▶ PAGE 207, "First, **why**, if species have descended from other species by fine gradations, **do we not everywhere see innumerable transitional forms?**
 - ▶ **Transitional forms which Darwin speaks of, are still missing because no such creatures exist. Just another part of the Greatest Hoax in History.**

 - ▶ DOES INANIMATE MATTER HAVE A THOUGHT PROCESS, OR A DESIRE TO CHANGE FROM IT'S STATE OF INANIMATENESS TO BECOME ANIMATE AND TAKE ON LIFE?
- ▶ ALL THE ABOVE REASONS, BASED UPON LOGIC, POINT TO A PURPOSEFUL CREATOR NOT RANDOM CHANCE

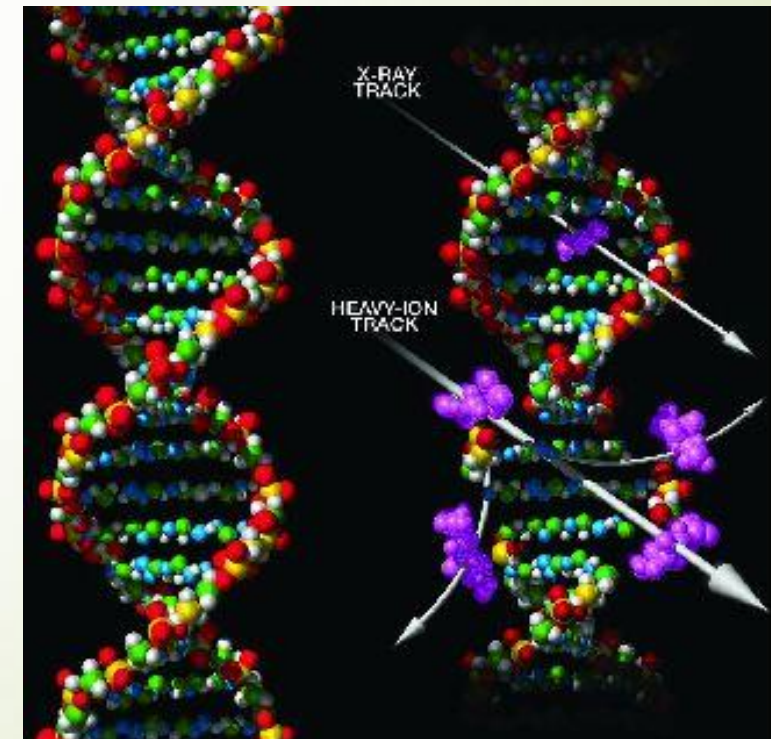

- ➔ AN INTELLIGENT DESIGNER WILL USE SIMILAR FEATURES IN VARYING FORMS, SIZES AND NUMBERS WHEN IT WORKS WELL. INTELLIGENT DESIGNER NOT RANDOM CHANCE LED BY CHAOS.

Similar Features: Creation or Evolution ?



- AN INTELLIGENT CREATOR DESIGNS HIS CREATIONS TO **REPRODUCE AND IMPROVE OVER TIME ON IT'S OWN.** (**MICRO-EVOLUTION NOT MACRO**)
- AN INTELLIGENT DESIGNER **ALLOWS HIS CREATIONS TO ADAPT AND EVOLVE TO CHANGING ENVIRONMENTS,** (A.K.A. **ADAPTATION PROCESS**) IN ORDER TO SURVIVE BETTER, (A.K.A. **SURVIVAL OF THE FITTEST**). (**MICRO-EVOLUTION NOT MACRO**)
- AN INTELLIGENT CREATOR IMPLANTS **LOGIC AND REASONING** TO HIS CREATION, SO HIS CREATION CAN GO IN SEARCH OF HIM.
 - (EVEN ATHEISTS USE THE SAME LOGIC ABOUT THEIR CREATOR; PLEASE WATCH "V__GER")

THE QUESTION OF GOOD: ARE YOU GOOD ENOUGH TO ENTER HEAVEN?

➤ STUDENT QUESTIONS:

- (1) "IF I'M A GOOD PERSON, WON'T GOD ALLOW ME TO GO TO HEAVEN?"
- (2) "HOW DO YOU RESPOND TO SOMEONE THAT DOESN'T PRACTICE BUT SAYS THEY BELIEVE IN DOING GOOD."

- 1) TO ANSWER THESE QUESTIONS, WE MUST FIRST DEFINE WHAT IS "GOOD".
- 2) POINT OUT THEIR MISUNDERSTANDING OF GOOD. FOR MAN'S STANDARD OF GOOD IS NOT GOD'S STANDARD OF "GOOD".
- 3) THE REASON THEY CANNOT POSSIBLY WORK THEIR WAY INTO HEAVEN.
 - 1) HOW MANY SINS DOES IT TAKE TO PREVENT US FROM ENTERING HEAVEN? (ONE)
 - 2) CAN A PERSON EVER "RIGHT" A PAST "WRONG", NO! WHY NOT? (EXPLAIN)(ALSO REMEMBER, WHEN I WRONG, I AM DOING WRONG AGAINST THE CREATOR NOT JUST THE CREATION)
- 4) EXPLAIN TO THEM WHY GRACE THROUGH JESUS CHRIST IS THE ONLY WAY.

WHAT IS “GOOD”

- ▶ THE RICH YOUNG RULER “GOOD TEACHER” (MAR.10:17-27, LUK.18:18-30) **“GOOD TEACHER, WHAT MUST I DO TO INHERIT ETERNAL LIFE?...WHY DO YOU CALL ME GOOD? JESUS SAID...NO ONE IS GOOD-EXCEPT GOD ALONE...”**
- ▶ **WHAT JESUS IS POINTING OUT TO THE YOUNG RULER AND TO US IS, DO YOU TRULY KNOW “GOOD” AS GOD DEFINES “GOOD”?**

WHAT HAPPENS TO THOSE WHO DIE WITHOUT HEARING ABOUT JESUS

- **DOES GOD REALLY SEND THEM ALL TO HELL?; HOW IS THAT A LOVING GOD?**
 - **UNFAIR BECAUSE THEY DIDN'T GET A CHANCE TO ACCEPT JESUS**
 - **FIRST LET'S CLARIFY: GOD DOES NOT SEND A SINGLE PERSON TO HELL**
 - **THE CHOICE TO ACCEPT OR REJECT CHRIST BELONGS TO THE INDIVIDUAL; THEREFORE, IT'S THE INDIVIDUAL WHO DECIDES WHERE HE/SHE WILL END UP**
 - **INSTEAD OF FOCUSING ON ALL OTHERS, LET'S FOCUS ON YOU. WHERE DO YOU WANT TO END UP?**
- **THE ASSUMPTION IN THESE QUESTIONS IS THAT THERE MUST BE SOME WHO ARE WORTHY OR DESERVING OF GOING TO HEAVEN.**
 - **IN THE ENTIRE HISTORY OF HUMANITY, HOW MANY PEOPLE WERE TAKEN TO HEAVEN BASED UPON THEIR OWN MERIT, OTHER THAN CHRIST?**
 - **ENOCH (GEN. 5:21-24) AND PROPHET ELIJAH (2KINGS 2:11)**
 - **DO YOU HONESTLY BELIEVE YOU DESERVE TO GO TO HEAVEN?**

THE BIBLE ANSWERED THIS QUESTION TWO THOUSAND YEARS AGO

- ▶ Rom. 2:12-16, “**All who sin apart from the law will also perish apart from the law, and all who sin under the law will be judged by the law.** For it is not those who hear the law who are righteous in God’s sight, but it is those who obey the law who will be declared righteous. (Indeed, when Gentiles, who do not have the law, do by nature things required by the law, they are a law for themselves, even though they do not have the law, since they show that the requirements of the law are written on their hearts, their consciences also bearing witness, and their thoughts now accusing, now even defending them.) This will take place on the day when God will judge men’s secrets through Jesus Christ, as my gospel declares.”

THE THREE GROUPS OF SINNERS

- MEN BELIEVE THEY ARE SO INTELLIGENT AND THOUGHTFUL IN THEIR QUESTIONS OF GOD; JUDGING HIM THROUGH THE ARROGANCE OF THEIR OWN MISUNDERSTANDING, BUT THE BIBLE ANSWERED THESE QUESTIONS ALMOST TWO THOUSAND YEARS AGO. EVERY GENERATION BELIEVES THEY ARE MORE INTELLIGENT THEN THE PREVIOUS, BUT IN VAIN THEY ASK THE VERY SAME QUESTIONS, OVER AND OVER, EACH GENERATION BELIEVING THEY ARE WISER THAN THE PAST GENERATION.
- SUCH IS THE FOLLY OF MEN, AND THE FOLLY OF MEN ONLY MAKES THE OMNIPOTENCE OF GOD BLARINGLY MORE APPARENT.

THE THREE GROUPS OF SINNERS

(Rom. 2:12-16)

- I. THOSE WHO SIN APART FROM THE LAW: DON'T KNOW ABOUT TEN COMMANDMENTS BUT ARE GOVERNED BY THE MORAL LAW WRITTEN UPON THEIR HEARTS.
- II. THOSE WHO SIN UNDER THE LAW: JEWS AND OTHERS WHO KNOW OF TEN COMMANDMENTS AND SHOULD FOLLOW THE COMMANDMENTS.
- III. THOSE WHO ARE SAVED BY GRACE: CHRISTIANS WHO HAVE ACCEPTED JESUS CHRIST AS THEIR SAVIOR, AND ARE NOT BOUND BY THEIR SINS.

CAN MAN LIVE A “GOOD LIFE” IN A FALLEN WORLD

- **JESUS' DEFINITION OF SIN:** “THE BEATITUDES” (MAT. 5:17-30, “...YOU HAVE HEARD, ‘DO NOT MURDER’, BUT IT TELL YOU THAT ANYONE WHO IS ANGRY WITH HIS BROTHER IS ALREADY SUBJECT TO JUDGMENT...BUT I TELL YOU, ANYONE WHO HAS LOOKED AT A WOMAN LUSTFULLY HAS ALREADY COMMITTED ADULTERY IN HIS HEART.”)
 - **IF YOU HAVE BROKEN EVEN ONE COMMANDMENT, YOU HAVE SINNED**
 - **JUST HAVING THOUGHT ABOUT THE ACT, MEANS YOU HAVE ALREADY COMMITTED THE SIN**
 - **“NONE ARE WORTHY.” DO YOU REALLY WANT TO TRY TO GAIN ENTRY UPON YOUR OWN MERITS?**
- **GOD, THROUGH HIS GRACIOUS BENEVOLENCE, HAS MADE A WAY FOR MEN, WHERE THERE EXISTS NO OTHER WAY.**
 - **E.G., GOD PROVIDED THE RAM SACRIFICE FOR ABRAHAM'S SON ISAAC**
 - **THIS TIME, GOD HAS PROVIDED HIS OWN SON, IN JESUS CHRIST, TO TAKE THE PLACE FOR OUR SACRIFICE**
- **ONLY JESUS PROVIDES ACCOUNTABILITY WITHOUT CONDEMNATION**

THE JUDGMENT OF MEN

- REV. 20:11-15: "...ANOTHER BOOK WAS OPENED, WHICH IS THE BOOK OF LIFE. THE DEAD ARE JUDGED ACCORDING TO WHAT THEY HAD DONE AS RECORDED IN THE BOOKS..."
- REV. 21:27: "NOTHING IMPURE WILL EVER ENTER IT, NOR WILL ANYONE WHO DOES WHAT IS SHAMEFUL OR DECEITFUL, **BUT ONLY THOSE WHOSE NAMES ARE WRITTEN IN THE LAMB'S BOOK OF LIFE.**"
- **WILL YOUR NAME BE WRITTEN INTO "THE BOOK OF LIFE"?**

WHEN I GET TO HEAVEN...

- I'VE OFTEN HEARD MEN EXCLAIM, "WHEN I GET TO HEAVEN, I'M GOING TO ASK GOD TO EXPLAIN ..." AS IF THEY ARE GOING TO DEMAND GOD TO EXPLAIN AND JUSTIFY HIS ACTIONS TO MEN.
- YOU KNOW WHAT? WHEN I GET TO HEAVEN, I WILL BE SPEECHLESS!
- BEING IN THE PRESENCE OF GOD WILL RENDER ME SPEECHLESS. I WILL SEE THE GRANDEUR OF HIS HEAVEN AND I WILL REALIZE HOW IRRELEVANT, IGNORANT, AND INSIGNIFICANT MY QUESTIONS ARE IN THE PRESENCE OF OUR REAL GOD.
- I WILL COWAR DOWN IN AWE OF HIS GRANDEUR.
- ONLY THEN, WILL I COMPREHEND FOR THE FIRST TIME IN MY LIFE, THE TRUE MEANING OF THE WORDS, "OUR GOD IS AN AWESOME GOD!",
- AND I WILL REMAIN SILENT IN HUMILITY AND AWE.

WHAT CHARLES DARWIN ADMITTED TO IN HIS BOOK

- “ON THE ORIGIN OF SPECIES BY MEANS OF
NATURAL SELECTION **OR THE PRESERVATION OF
FAVOURED RACES IN THE STRUGGLE FOR LIFE**”
- NOTE THE SECOND HALF OF THE BOOK’S
ORIGINAL TITLE WHEN IT WAS ORIGINALLY
PUBLISHED, BUT I RARELY QUOTED IN THE
SCHOOLS BY EVOLUTIONISTS WHO PROMOTE
DARWIN’S IDEAS.

Conclusions about Darwin's theory

- Evidence clearly proves Darwin was WRONG. Over 165 years since his book was written. **Why do the so many scientists and schools promote Darwin's ideas?**

Darwin's book, "ON THE ORIGIN OF SPECIES BY MEANS OF NATURAL SELECTION **OR THE PRESERVATION OF FAVOURED RACES IN THE STRUGGLE FOR LIFE**",

published in Nov. 1859, came out at an opportune time: JUST BEFORE U.S. CIVIL WAR.

- Did the problems leading up to the American Civil War make it more popular among the wealthy and influential slave owners in England, France, and America?

WHAT DARWIN ADMITTED

- PAGE 207, “Long before the reader has arrived at this part of my work, **a crowd of difficulties will have occurred to him. Some of them are so serious that to this day I can hardly reflect on them without being in some degree staggered...**”
 - **A: DARWIN ADMITS THERE ARE SERIOUS PROBLEMS WITHIN HIS THEORY WHICH NEED TO SHOW PROOF IN THE FUTURE FOR HIS THEORY TO BE CORRECT. ALL HIS CITED PROBLEMS STILL EXIST; EVERY SINGLE ONE OF THEM.**
- PAGE 207, “First, **why**, if species have descended from other species by fine gradations, **do we not everywhere see innumerable transitional forms?**”
 - **A: NOT ONE SINGLE TRANSITIONAL FORM SEEN, EVEN 165 YEARS AFTER DARWIN’S BOOK WAS PUBLISHED.**
- PAGE 207, “...**Why is not all nature in confusion, instead of the species being, as we see them, well defined?**”
 - **A: BECAUSE NATURE IS NOT RANDOMLY EVOLVED FROM CHAOS, BUT CREATED AND DESIGNED BY AN INTELLIGENT DESIGNER.**

- ▶ PAGE 208, “Fourthly, how can we account for species, when crossed, being sterile and producing sterile offspring, whereas, when varieties are crossed, their fertility is unimpaired.”
 - ▶ **A: THIS PROVES THAT DIFFERENT KINDS CANNOT BE EVOLVED FROM EACH OTHER, SINCE EVEN DIFFERENT SPECIES ONLY PRODUCE STERILE OFFSPRING.**
- ▶ PAGE 208, “But, as by this theory innumerable transitional forms must have existed, why do we not find them embedded in countless numbers in the crust of the earth?”
 - ▶ **A: We could also question, if the older species were poor and required evolution, why do so many species, which have around for millions of years, such as crocodiles, sharks, and bacteria, still exist in proliferation. For example, why do Algae and squids outnumber most of the higher developed lifeforms in the ocean.**

WHAT DARWIN ADMITTED

- ▶ PAGE 228, REFERING TO THE FORMATION OF THE INCREDIBL DESIGN OF THE EYE, “But may not this inference be presumptuous? **Have we any right to assume that the Creator works by intellectual powers like those of man?”**
 - ▶ **A: NOT ONLY THE EYE, BUT THE DNA, THE FUNCTIONING COMPONENTS AND SYSTEMS OF EVEN THE SIMPLEST BACTERIA ARE IMPOSSIBLE TO BE EVOLVED.**
- ▶ PAGE 229, “If it, could be demonstrated that any complex organ existed, which could not possibly have been formed by numerous, successive, slight modifications, my theory would absolutely break down.”
 - ▶ **A; IRREDUCIBLE COMPLEXITY OF EVERY SINGLE COMPONENT OF THE FIRST LIVING CELL PROVES, BY DARWIN’S OWN WORDS, THAT “HIS THEORY WOULD ABSOLUTELY BREAK DOWN”.**
- ▶ PAGE 318, REFERING TO SUDDEN CHANGES, “...and of such complex and wonder co-adaptations, he will not be able to assign a shadow of an explanation. He will be forced to admit that these great and sudden transformation have left no trace of their action on the embryo. To admit all this is, as it seems to me, to enter into the realms of miracle, and to leave those of science.”
 - ▶ **A: THE CAMBRIAN PERIOD PROVES THE EXPLOSION OF DIVERSE LIFEFORMS WITHOUT ANY PRESIDING FORMS OF LIFE SIMILAR TO THEM IN THE PRIOR FOSSIL PERIODS.**

WHAT DARWIN ADMITTED

- ▶ PAGE 412, “In the sixth chapter, I enumerated the chief objections...One, namely the distinctness of specific forms, **and their not being blended together by innumerable transitional links, is a very obvious difficulty.**”
 - ▶ **A: THE MISSING LINK IS MISSING, BECAUSE IT DOES NOT EXIST.**
- ▶ PAGE 452, “**Several difficulties**...the sudden manner in which several groups of species first appear in our European formations; the almost entire absence, **as at present known, of formations rich in fossils beneath the Cambria Strata, are all undoubtedly of the most serious nature.**”
 - ▶ **A: GEOLOGICAL EVIDENCE CONFIRMS THIS PROBLEM STILL PERSISTS, EVEN AFTER 165 YEARS OF SEARCHING.**
